RFQ: Mobile Medical Services for Street Medicine Program

Central Pines Regional Council (CPRC) is issuing a Request for Quotes (RFQ) and solicitating responses from qualified and licensed medical and/or behavioral health providers to deliver mobile clinical and mental health services as a part of a Street Medicine Pilot Program in Durham County, North Carolina. This program aims to meet the medical and mental health needs of individuals experiencing homelessness, or at risk of homelessness, by delivering services in non-traditional and community-based settings.

Qualified applicants may include individual providers or organizations that employ licensed professionals such as MDs, Dos, NPs, PAs, LCSWs/LCPCs, or other licensed clinicians.

Scope of Work

Selected providers will be expected to:

- 1. Deliver direct medical care in community settings across Durham County. Providers may respond to one or both types of service delivery based on their expertise, availability, or other needs:
 - a. Encampment & Outreach-Based Care: Delivered directly in unsheltered settings such as encampments, sidewalks, and other public places, in coordination with outreach teams.
 - b. Pop-Up Clinics: Mobile clinics set up at shelters, service hubs, or other community partner sites to provide semi-structured care in a more stationary but still low-barrier format.
 - c. In both scenarios, CPRC has an outreach team that can attend and provide support for service delivery. However, if you feel strongly about needing an additional provider on your team, include this narrative in your proposal.
- 2. Collaborate with a multidisciplinary team.
- 3. Refer and coordinate care with local clinics, hospitals, or social services.
- 4. Participate in mobile outreach and team meetings.

5. Document care in a secure, HIPAA-compliant system.

Minimum Qualifications

- a. Active MD, DO, NP, or PA license in North Carolina.
- b. Ability and willingness to work in a mobile capacity in Durham County.
- c. Familiarity with trauma-informed and harm-reduction care.
- d. Malpractice or liability insurance.

- 1. Rate: Provide a proposed hourly or shift-based rate for each individual on your team.
- 2. Availability: Provide weekly or monthly availability for mobile outreach, including each member of your team (this can include an anticipated number of service hours per week/month).
- 3. Resume/CV: Highlight relevant experience, credentials, and community-based care.
- 4. Proof of Licensure: Active NC license.
- 5. Written Responses (maximum of 500 word for each question):

Please respond to each of the following prompts. In addition to describing your experience and approach, include any support, resources, or system-level needs that would help you and your team deliver high-quality care in a mobile, street-based setting.

- a. What types of medical services can you and your team provide?
- b. How do you ensure safety and privacy during mobile-based care?
- c. What is your experience working with unhoused or vulnerable populations?
- d. How do you coordinate referrals and continuity of care with other providers or systems?
- e. Do you have experience working within Durham County or existing partnerships with medical,

- behavioral health, or housing/social service providers in the region?
- f. When do you anticipate being able to start? *CPRC is looking to advance agreements*with providers who can begin as early as January 2026. *CPRC is also looking to*work with providers who can support this effort until at least September 30, 2026.
