A Year of Transition

Lee Worsley, Executive Director



I am pleased to submit my recommended Triangle J Council of Governments (TJCOG) budget for July 1, 2023 through June 30, 2024, as our Charter requires. The year ahead will be one of transition for our organization as we continue to evolve to meet the needs of the region, reflected through many exciting changes, including:

Welcoming the Durham-Chapel Hill-Carrboro Metropolitan Planning Organization (DCHC MPO) to Triangle J on July 1, 2023. All eleven DCHC employees will become TJCOG

employees, bringing our total number of employees close to 60. DCHC will remain policy independent and report to the DCHC Policy Board. This is important since there are two MPOs in our region and we serve both MPOs in other ways.

We are poised to kick off renovation and construction of our new and improved offices at 4307 Emperor Boulevard. We will increase our footprint from roughly 9,500 square feet to 21,000 square feet. The centerpiece will be an expanded meeting space that can accommodate over 100 people, enabling us to become the "Central" hub for local governments and stakeholders to convene and collaborate.

TJCOG will roll out a new brand, including a new name, logo, and style for the organization. You can see hints of the new brand in this budget message!

During Fiscal Year 2023-2024 we will build upon the Grant Assistance program's early successes in 2022-23 on behalf of fifteen member governments. The team reviewed 400+ funding opportunities, submitted 60 grant applications totaling \$13M+, and received \$3.03M in funding, and will administer \$1.6M of awarded grants to mitigate local capacity concerns.

Our technical assistance to local government members continues. This includes intensive engagement in the Town of Micro (Johnston County) as they work through a Fiscal Accountability Agreement with the State Local Government Commission.

We have begun discussing the need for a Regional Vision & Strategy - our Connected Region Plan. We have received broad-based support for moving forward with this important planning process. I will discuss this more with the Board of Delegates during my budget presentation on April 20.

The Budget

The recommended budget for TJCOG for Fiscal Year 2023-2024 is \$40,443,100. The budget reflects continued alignment between our budget and strategic focus areas, and a need for robust investment in our operations to maintain services to our local governments.

Member Investments

This year, member investments (dues) from local governments are recommended to increase from \$0.39 to \$0.41 per capita. This is the first dues increase in over 20 years. Additionally, the threshold for dues to decrease to \$0.20 per capita is recommended to increase from 150,000 to 200,000. Member investments are calculated by the population of municipal members and the unincorporated population of county members.

Indirect Rate

TJCOG receives funding for our administrative functions through an indirect rate calculated on each program's salaries and fringe benefit costs. The indirect rate allows each program to pay its fair share of administrative costs and reduces the burden placed on flexible funds, such as member investments, that are essential for our proactive work.

The recommended indirect cost rate for 2023-2024 is 53.7071%. This is the first increase in our indirect rate percentage in 8 years, due primarily to the required furnishings and technology needed for our newly renovated space, as well as the need to replace our financial system. It is anticipated that this will be a one-year spike in the indirect rate and the 2024-2025 indirect rate will reduce to be comparable to recent years.

Recruitment & Retention

TJCOG continues to work to mitigate a tight job market for public sector employees and significant pressure on public sector salaries. Thanks to the Board of Delegates' support, we can continue providing attractive benefits. The recommended budget includes the following adjustments to salaries:

- A 3% market adjustment for all employees, effective at the beginning of Fiscal Year 2023-24. The adjustment will also shift minimum salaries up by 3% for all positions in the Pay and Classification Plan.
- A 3% merit increase opportunity for employees not in a probationary period and in their position for at least one year. The 3% merit award is determined by supervisors and is based on the employee meeting expectations on their work plan. Merit increases are effective at the beginning of Fiscal Year 2023-24.

The recommended budget includes 4 full-time new positions and 11 new MPO positions:

- A full-time Planner I to assist with Safe Routes to School Grant award
- An Accounting Technician II/HR Technician and Contracts/Procurement Specialist to assist with increased administrative requirements from DCHC transition and continued merger of finance operations with Mid Carolina Regional Council
- A UNC School of Government NC LEAD Fellow to assist the Town of Micro full time. The position will be reimbursed by the Town.
- 11 new MPO positions will transfer from the City of Durham to TJCOG. One staff member from the Transportation Focus Area will transfer to DCHC.
- The budget does not include the position at this point in time, but adding a full-time Principal Planner will be discussed with the Board on April 20. This position is needed to manage the Connected Region effort.
- With the additions and the one transfer, there is a proposed net increase of 14 new positions in the recommended budget. That will move to 15 new positions if the Principal Planner is added.

Our Board

TJCOG's Board of Delegates includes one elected official from each member county and municipality served by the organization. The full board sets policy, guides programming, and discusses regional challenges for TJCOG. TJCOG's Executive Committee includes all seven county delegates and one municipal representative from each county. The Executive Committee conducts business for the organization in months when the Board of Delegates does not meet.

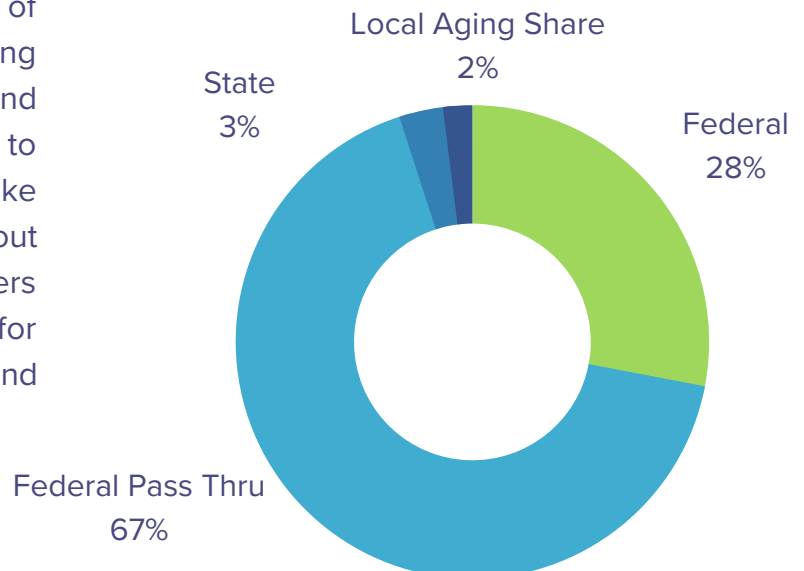

Aging & Human Services

The Year Ahead

TJAAA continues to utilize the American Rescue Plan funding and other special COVID-19 funding to assist the aging network and the older adults they serve with pandemic recovery. Enhancing long-term services and supports for vulnerable older adults, promoting awareness and prevention of elder abuse, and addressing social isolation are at the top of the AAA's priority list. Additionally, staff continue to administer the Older American's Act service funding, which includes providing reimbursement for services provided, reporting to the state and federal government, education and information, and technical assistance to its service network.

Aging & Human Services Focus Area projects included in the recommended budget:

Planning & Administration

Funding for the implementation of the Area Plan for Aging & Human Services and for the operational needs of the AAA in providing information brokerage, funds administration and quality assurance, and advocacy.

Family Caregiver Support Program

The TJAAA encourages the development of resources and services at the local level to support family caregivers of aging adults and persons with disabilities and provides administrative oversight and technical assistance on the use of the National Family Caregiver Support Program funds for education, resource information, support groups, counseling, outreach, and supplemental services.

Long-Term Care Ombudsman Program

The Long-Term Care Ombudsman Program advocates for residents in nursing homes, adult care homes, and family care homes by investigating concerns from residents and family members related to care and treatment and assists residents in exercising their rights.

Elder Abuse Awareness & Prevention

The TJAAA provides public education and outreach to raise awareness and to help identify and prevent abuse, neglect, and exploitation of adults and those with disabilities.

Aging & Human Services Focus Area projects included in the recommended budget:

Home & Community Care Block Grant

Funding for direct services to eligible adults, aged 60 and older. Services are provided in accordance with the requirements of the federal Older Americans Act and the standards set forth by the NC Division of Aging & Adult Services. Examples include senior center services, in-home services, congregate and home-delivered meals, and transportation.

Budget: \$9,756,104

Fans/Heat Relief

Energy companies provide box fans, on a limited basis, room air conditioners, to aging adults lacking sufficient home cooling.

Budget: \$17,360

Local Contact Agency

The TJAAA provides assessment for eligibility for Money Follows the Person, a Medicaid waiver program that assists qualifying adults to transition from skilled nursing care to community living.

Legal Services Assistance

Funding provides for legal assistance services to adults, age 60 and older, especially for those who are institutionalized or medically fragile, low-income, rural, non-English speaking, or unable to leave their homes to receive services.

Health Promotion/Disease Prevention

Funding for evidence-based programs addressing health promotion and disease prevention that have been proven to benefit aging adults by reducing injuries from falls, helping manage chronic conditions, and reduce unnecessary emergency room visits and hospitalizations.

Senior Center General Purpose

Senior Center General Purpose funding is provided to senior centers designated by the NC Division of Aging & Adult Services (NCDAAS) as meeting the requirements of a Multi-Purpose Senior Center. Funds may be used for personnel costs, building and maintenance, supplies, outreach, or education.

MIPPA VI

The Medicare Improvements for Patient and Providers Act (MIPPA) makes grant funds available for targeted outreach to assist qualifying low-income individuals pay for Medicare premiums or prescription drug plan costs by providing targeted outreach.

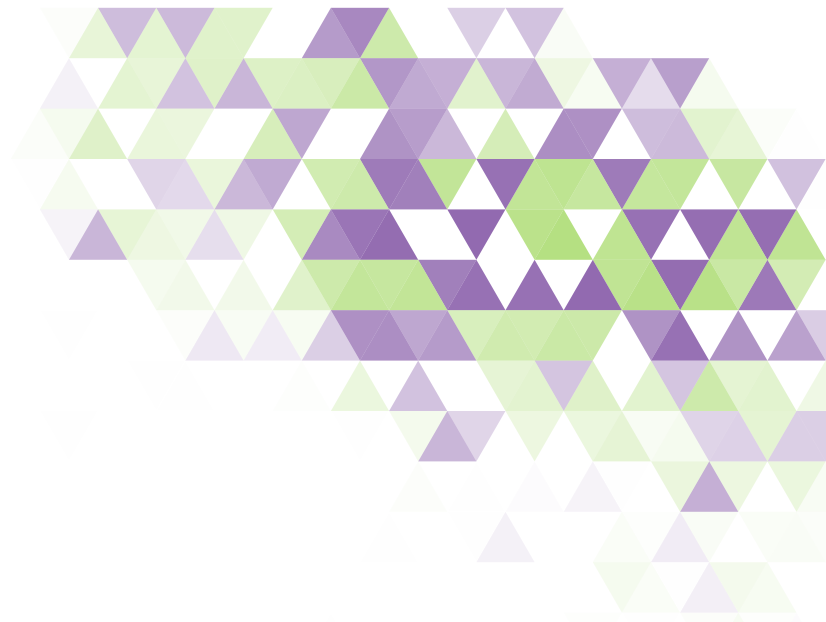

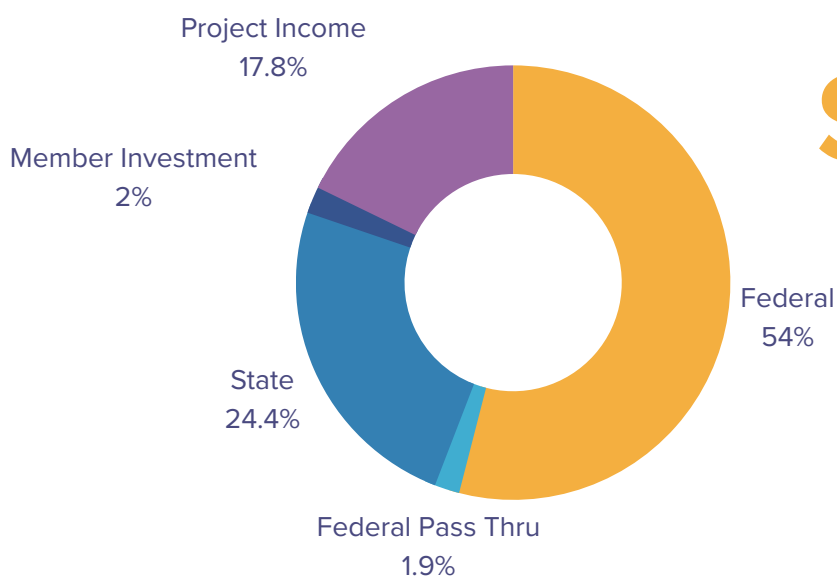

Highlights in the Coming Year

Community & Economic Development staff are administering a recently awarded EPA Brownfields grant in the amount of \$500,000, to support Phase I and Phase II assessments in Fuquay-Varina and Wake Forest. These assessments can lead to clean up efforts, alleviating relevant soil, air, and water contaminants, while fostering redevelopment and economic activity. A new partnership with North Carolina Biotechnology Center will support their Ambassador Program which aims to create opportunity for historically excluded populations to gain access to careers in life sciences. This effort is funded by an Economic Development Administration (EDA) Build Back Better award.

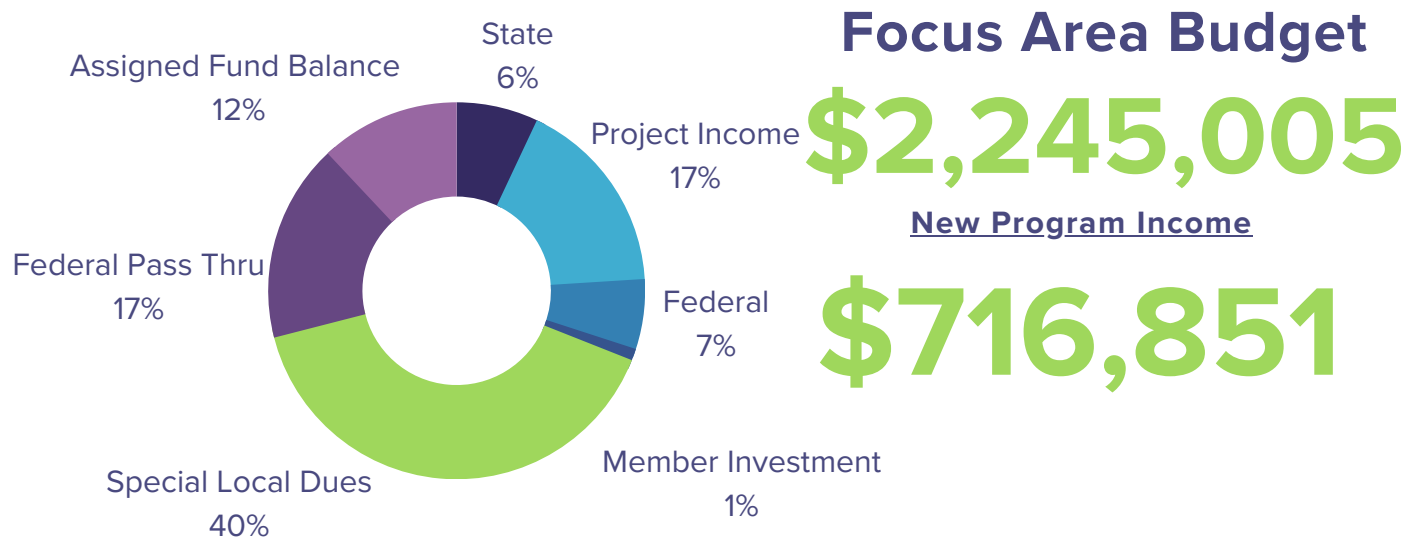

Highlights for the Year Ahead

The program is looking forward to building on the success of the Solarize the Triangle Program through a second round, called Solarize the Triangle '23, and implementing rooftop solar grant programs for low to moderate income residents. A new staff member will focus on leading regional recovery and resilience efforts and working with local partners to address episodic events like severe storms and help communities adapt to our changing climate - anticipated extreme heat, more flooding, and more risk of drought. Finally, we plan to begin leading our communities through the first regional climate plan, which will make participating communities eligible for competitive federal implementation funding and identify ways we can work together to reduce greenhouse gas emissions.

Triangle Area Water Supply Monitoring Project

A collaboration with the United States Geologic Survey (USGS), this project allows local communities to measure water quality conditions and records long-term trends in water quality in streams, rivers, and lakes that feed water supply sources.

Triangle Water Supply Partnership

Formed in 2018 by 13 jurisdictions and water systems in the Triangle, this partnership conducts planning and coordination for the Jordan Lake Watershed, including an important interconnection model.

This partnership with the NC Department of Environmental Quality and Rebuilding Together of the Triangle, a nonprofit serving low income residents of our region, allows repair of failing septic systems for low income residents which improves local water quality and adds to home value.

A cooperative effort between local governments, state agencies, and nonprofit organizations to protect water quality in the Tar-Pamlico, Neuse, and Cape Fear River Basins through public education and outreach.

LMI Solarize*

As part of the Solarize the Triangle effort some participating communities have allocated funding to grant rooftop solar photovoltaic systems to be installed on the homes or rental units of low to moderate (LMI) residents in their communities. These solar systems will reduce the electricity usage and bill by approximately 50% for a typical household. TJCOG is working with nonprofit community partners who serve the LMI residents of the Triangle to identify possible recipients for these solar photovoltaic systems.

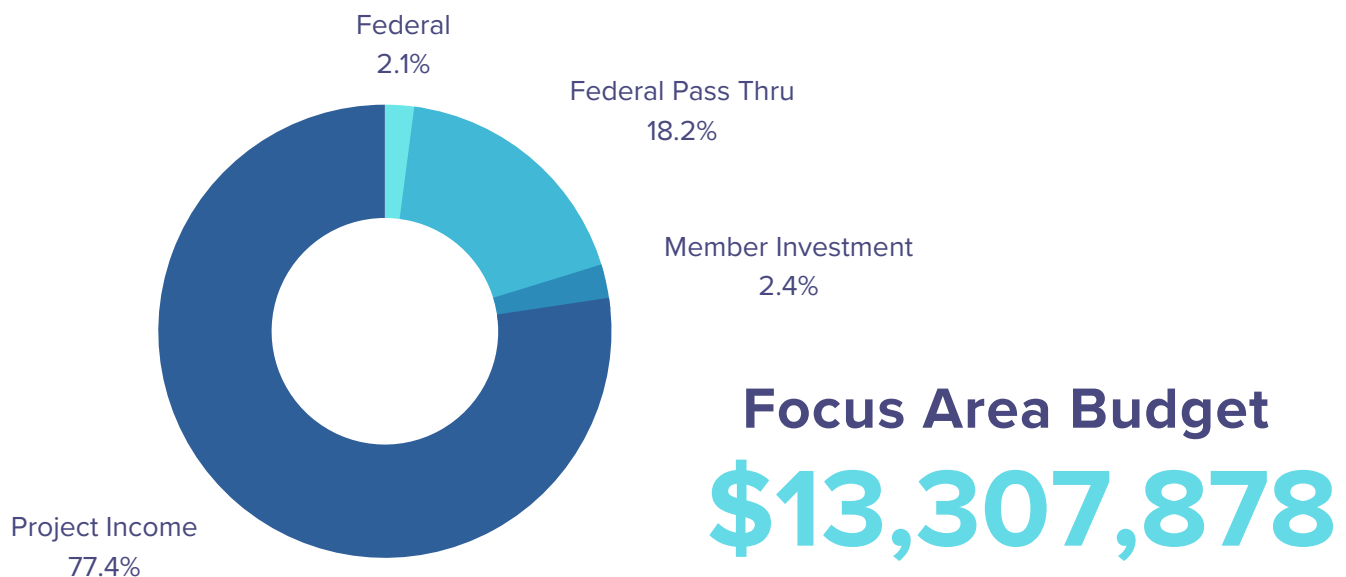

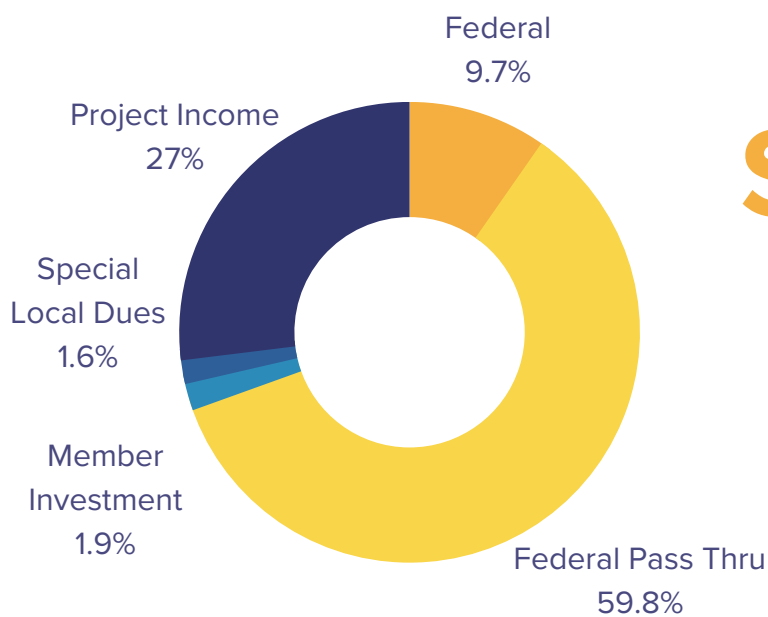

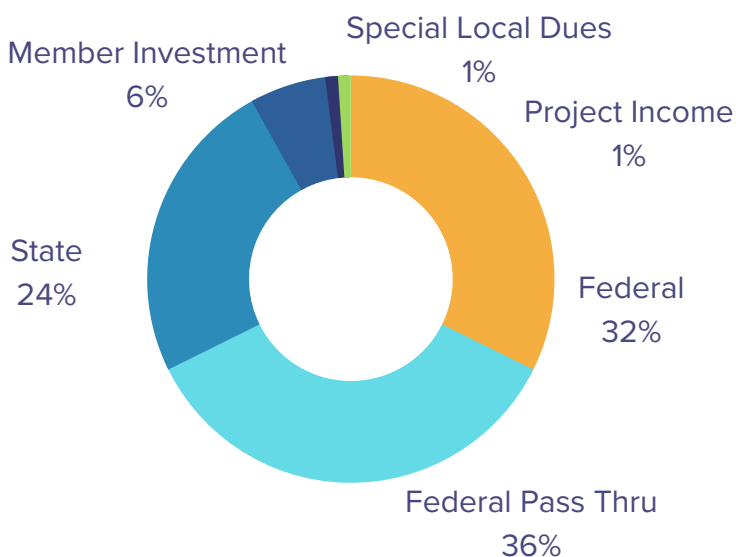

Highlights in the Year Ahead

This will be an exciting year for our Mobility & Transportation focus area. Thanks to additional funding from NCDOT, we will be expanding our Safe Routes to School program by creating a new dedicated staff position focused on this work. Our work in clean transportation continues to grow, with two new projects focused on electric vehicles and zero-emission vehicles. Through a Federal "Safe Streets for All" grant, we will be working on regional data collection on road safety and the development of pilot road safety plans for the Town of Morrisville and Lee County/City of Sanford/Town of Broadway. And we welcome the Durham-Chapel Hill-Carrboro MPO to our team as we will become the MPO's new lead planning agency.

The program links state policy and funding with local and regional service providers.
